Representatives from GDOT were present to speak regarding construction of the I-75 South Metro Express Lane. This project begins along I-75 south of Atlanta at SR 155 / McDonough Road and ends at SR 138 / Stockbridge Hwy, and includes approximately 12 miles of managed lanes. The proposed project consists of the addition of two reversible express lanes located within the median of I-75, to be managed by a variable priced tolling system. These lanes will be designed to improve traffic flow, increase options for motorists and transit and registered vanpool customers, provide reliable trip times, create jobs and bring economic benefits to the residents of this region.
