The City of Jonesboro Mayor and Council held the Regular meeting on Monday, October 8th, 2012. The meeting was held at 7:03 pm at the Jonesboro Police Department, 170 South Main Street, Jonesboro, Georgia.

Considered approval of minutes: Worksession meeting of September 4th, 2012 and Regular meeting of September 10th, 2012. Approved. [*Motion: Sebo, 2nd: Mann, Vote: Unanimous*].

- C. Considered rescinding vote taken on September 10th, 2012 regular meeting of “30” day business turnaround” if warranted. Item C was omitted by Mayor Day. Postponed until November 12th, 2012 Regular Meeting.
- D. Considered awarding contract for Fayetteville Road sidewalk project. Approved and accepted the contract for C & G Concrete. Approved. [*Motion: Compton, 2nd: Norrington, Vote: Unanimous*].
- E. Considered new roof at Jonesboro Police Department. Postponed until November 12th, 2012 Regular meeting.
- F. Considered services of Mr. Bill Johnston, Strategic Planning Initiatives, LLC. (Planning, zoning, economic development, annexation). Approved. [*Motion: Sebo, 2nd: Segner, Vote: Yea: Sebo, Segner, Norrington, Mann; Nay: Compton*].
- G. Considered construction of City storage building at Public Works. Committee was appointed by Mayor Day. Omitted from agenda by Mayor Day and postponed until November 12th, 2012 Regular Meeting.
- H. Considered motion to enter Executive Session for the purposes of litigation, personnel and real estate matters. Item H omitted from agenda by Mayor Day.
- I. Considered resuming regular meeting. Item I omitted from agenda by Mayor Day.
- J. Considered vote, if any, on matters discussed in Executive session. Item J omitted from agenda.
- K. Considered purchase of new lawn mower. Approved. [*Motion: Compton, 2nd: Norrington, Vote: Unanimous*].
- L. Considered proposed ordinance related to Section 86 Zoning; Conditional Use – number of days authorized for business turn around, as presented by City Attorney Steve Fincher. Committee appointed by Mayor Day. No vote taken. Postponed to November 12th, 2012 Regular Meeting.
