The City of Jonesboro Mayor and Council held their Regular meeting on Monday, June 10<sup>th</sup>, 2013. The meeting was held at 7:00 pm at the Jonesboro Police Department, 170 South Main Street, Jonesboro, Georgia.

Considered approval of minutes: Worksession of May 6<sup>th</sup>, 2013; and Regular Meeting of May 13<sup>th</sup>, 2013. Approved as written. [*Motion: Segner; 2<sup>nd</sup>: Compton; Vote: Unanimous*].

- B. Considered implementing policy of ‘no smoking’ on City property inclusive of city parks; and posting signage stating ‘SMOKE FREE ZONE’. Approved. [*Motion: Sebo; 2<sup>nd</sup>: Wiggins; Vote – Yea - Wiggins, Mann, Sebo, Segner, Compton; Nay – Norrington*].
- C. Considered review of revised Lee Street park survey – authorizing the Mayor to move forward on all proposed phases of resident involvement, meetings, committees and any other aforementioned items discussed in the Worksession held June 3<sup>rd</sup>, 2013. Approved. [*Motion: Norrington; 2<sup>nd</sup>: Mann; Vote: Unanimous*].

- D. Considered expenditure of \$39,710.49 of SPLOST funds to supplement CDBG funds for Carriage Lane project. Approved. [*Motion: Sebo; 2<sup>nd</sup>: Norrington; Vote: Unanimous*].
- E. Considered approval of Intergovernmental Agreement between the City of Jonesboro and Clayton County Elections and Registration for the loan and use of voting equipment for the November 2013 election Approved. [*Motion: Mann; 2<sup>nd</sup>: Norrington; Vote: Unanimous*].
- F. Considered motion to enter Executive Session for the purpose of discussing personnel matters. Approved. [*Motion: Norrington; 2<sup>nd</sup>: Mann; Vote: Unanimous*].
- G. Considered motion to resume Regular meeting. Approved. [*Motion: Mann; 2<sup>nd</sup>: Compton; Vote: Unanimous*].
