CALLED COUNCIL MEETING MINUTES
APRIL 9TH, 2014 – 5:00 p.m.

The City of Jonesboro Mayor and Council held a Called meeting on Wednesday, April 9th, 2014. The meeting was held at 5:00 p.m. at the Jonesboro Police Department, 170 South Main Street, Jonesboro, Georgia.

NEW BUSINESS (Items A-E):

- A. Considered Mike Foster’s employment appeal to City Council. Appeal procedure began with L’Erin Barnes representing the City of Jonesboro Police Department. Attorney Barnes presented her case. Mr. Mike Foster’s Attorney was not present so he represented himself. Mr. Foster presented his rebuttal. Councilmember Segner and Mayor Day asked Mr. Foster a few questions and Mr. Foster replied.

- C. Considered motion to resume Regular meeting. Approved. [*Motion: Bruce, 2nd: Powell; Vote: Unanimous*].
- D. Considered vote, if any, on matters discussed in Executive Session. Motion made to approve the minutes of Executive Session. [*Motion: Sebo, 2nd: Norrington; Vote: Unanimous*]. Motion made to uphold the decision made by the City of Jonesboro to terminate Mike Foster. Approved. [*Motion: Sebo, 2nd: Norrington; Vote: Unanimous*]. Motion made to approve an increase in pay of \$2080.00 annually for Pat Daniel. [*Motion: Bruce, 2nd: Norrington; Vote: Unanimous*]. Motion made to approve an increase in pay to \$14.50 for Hydee Griffin. Approved. [*Motion: Wiggins, 2nd: Norrington; Vote: Unanimous*].
- E. Considered motion to adjourn. Approved. [*Motion: Wiggins, 2nd: Norrington; Vote: Unanimous*].
