CALLED COUNCIL MEETING MINUTES
JUNE 26TH, 2014 – 6:00 p.m.

The City of Jonesboro Mayor and Council held a Called meeting on Thursday, June 26th, 2014. The meeting was held at 6:00 p.m. at the Jonesboro Police Department, 170 South Main Street, Jonesboro, Georgia.

Mayor Day called the meeting to order at 6:00 p.m.

NEW BUSINESS (Items A-E):

- A.** Discussed preliminary drawings of structures at Lee Street Park. Mayor Day provided the Councilmembers and citizens with copies of the Park and the proposed plan, and explained the documents. Discussion ensued.
- B.** Considered bids to alleviate moisture and mold in the City Hall basement. Councilmember Segner made a motion to contact two environmentalist companies to inspect the basement and access the mold. Motion did not carry due to lack of a 2nd. Approved to hire Nu-Wall Restorations for \$12,675.00. [*Motion: Powell, 2nd: Norrington; Vote: Yea – Norrington, Powell, Segner, Sebo; Nay – Wiggins, Bruce.*].
- C.** Considered hiring an Executive Assistant/Development Director at City Hall. Councilmember Powell made a motion to postpone this until a City Administrator/Manager is in place. Denied. [*Motion: Powell, 2nd: Norrington; Vote: Yea – Powell, Norrington, Bruce; Nay – Sebo, Segner, Wiggins, Day.*] Revisited this item. Motion was made by Councilmember Sebo to advertise and hire an Executive Assistant/Development Director. Approved. [*Motion: Segner, 2nd: Sebo; Vote: Yea – Sebo, Segner, Wiggins, Bruce, Norrington; Nay - Powell*].
- D.** Considered temporary raise for Staff at City Hall: Pat Daniel, Sandra Meyers and Robin Cave of \$5.00 per hour until additional personnel are added. Retroactive to: April 1, 2014. Motion was made by Councilmember Powell to award bonuses of \$2,500 each instead of hourly pay raises to the City Hall Staff: Pat Daniel, Sandra Meyers and Robin Cave. Approved. [*Motion: Powell, 2nd: Sebo; Vote: Yea- Norrington, Powell, Segner, Sebo; Nay – Wiggins, Bruce*].
- E.** Considered motion to adjourn. Approved. [*Motion: Norrington, 2nd: Sebo; Vote: Unanimous*].
