The City of Jonesboro Mayor and Council held their regular monthly meeting on November 14, 2005 at 170 South Main Street , Jonesboro , GA 30236 at 7:00pm. The following were in attendance:

**Minutes Approved:** Councilman Norrington made a motion to approve the October minutes as presented. Councilwoman Wenz seconded. The motion carried unanimously.

**Agenda Amendment:** Mayor Day requested a motion to amend the agenda to strike Item D-Pick up Waste and Recyclables. Councilman Norrington motioned to amend the agenda by striking "Item D" Councilwoman McDonald seconded. The motion carried unanimously.

**Home Occupation:** Kameron Burrell, 1500 Sunnybrook Drive ; requested a home occupational license in order to operate as a transporter of deceased bodies from their place of death. Councilwoman Meadows made a motion to approve a home occupational license to Burrell Removal and Transport Services to Kameron Burrell. Councilman Wiggins seconded. The motion carried unanimously.

**CDBG RESOLUTION 05-04:** Joel Logan reviewed and updated the council on the CDBG projects the city has undertaken; i.e. Spring Street Storm Water Drainage, Wilburn Street Sidewalk repairs and additional parking at Massengale Park . Mayor Day read CDBG Resolution 05-04 which request additional funding for city projects and Mayor Day asked for a motion to approve this resolution. Councilman Norrington made a motion to approve CDBG Resolution 05-04. Councilman Yonce seconded the motion. The motion carried unanimously.

**Electrical Services:** Mayor Day reviewed the two RFPs for Electrical Services.

Georgia Cabling & Electric and Triple "E" Electrical Services. Councilwoman McDonald recused herself from any decision or discussion. Mayor Day asked council for questions or discussion. The services offered and the hourly rates were reviewed. Councilwoman Wenz motion to accept Triple "E" Electrical Services proposal. Councilman Wiggins seconded the motion. The motion carried unanimously with Councilwoman McDonald abstaining.

**City of Ethics**: City Manager Jon Walker reviewed the City of Ethics program which covers the city council, the Downtown Development Authority and the Historic Preservation Commission. The attorneys are reviewing the program and Mr. Walker will have copies for the council for the December agenda.

**Executive Session**: Councilwoman McDonald made a motion to go into Executive Session to discuss personnel matters and pending litigation. Councilwoman Wenz seconded the motion. The motion carried unanimously.

Councilwoman Wenz made a motion to resume Regular Session. Councilman Norrington seconded. The motion carried unanimously.

### **OTHER BUSINESS**

**Conditional Use Permit**: Councilwoman McDonald made a motion for the council to reconsider the Conditional Use Permit for 210 Fayetteville Road at the December meeting. Councilman Norrington seconded the motion. The motion carried unanimously.

Mayor Day read the dates of upcoming meetings and events which included the Public Hearing on the 2006 Proposed Budget set for November 29<sup>th</sup> at 6:00pm.

There being no further business, Councilman Norrington made a motion to adjourn. Councilwoman McDonald seconded. The motion carried and the meeting was adjourned.
