Bid/Proposal Bonds, Payment Bonds, Performance Bonds - A five percent (5%) Bid Bond is required of all contractors submitting a proposal. The selected Contractor shall furnish separate Performance and Payment Bonds, each in a sum equal to the amount of the Contract Price, the Performance Bond conditioned upon the performance by the Contractor of all undertakings, covenants, terms, conditions, and agreements of the Contract Documents, and the Payment Bond conditioned upon the prompt payment by the Contractor to all persons supplying labor and products in the execution of the work provided by the Contract Documents. Such Bonds shall be executed by the Contractor and a corporate bonding company licensed to transact such business in the State of Georgia and listed in the Department of Treasury's publication of companies holding certificates of authority as acceptable surety on Federal bonds and as acceptable reinsuring companies (Treasury Department Circular Number 570). The expense of these Bonds shall be borne by the Contractor.
